

MULTI-OFFICE ASSUME IDENTITY FORM

THE IMLS MEMBER GRANTED ASSUME IDENTITY ACCESS MUST TAKE THE INPUT AND MAINTENANCE CLASS BEFORE ACCESS WILL BE GRANTED. IT MAY TAKE UP TO 3 BUSINESS DAYS FOR ACCESS TO GRANTED.

This form allows Assume Identity privileges for Agents/Admins who reside in different brokerages.

There will be a \$15 fee applied to your account. This fee will be paid with the CC you have on file, or payment must provided before completion.

Access will be granted for one (1) year. A new form must be submitted 30-days before the end of this contract to ensure access is not interrupted.
