



MULTI-OFFICE ASSUME IDENTITY FORM

THE IMLS MEMBER GRANTED ASSUME IDENTITY ACCESS MUST TAKE THE INPUT AND MAINTENANCE CLASS BEFORE ACCESS WILL BE GRANTED. IT MAY TAKE UP TO 3 BUSINESS DAYS FOR ACCESS TO GRANTED.

This form allows Assume Identity privileges for Agents/Admins who reside in different brokerages.

There will be a \$15 fee applied to your account. This fee will be paid with the CC you have on file, or payment must be provided before completion.

Access will be granted for one (1) year. A new form must be submitted 30-days before the end of this contract to ensure access is not interrupted.

By granting another IMLS Member access to assume an agent's identity within your brokerage, you understand the potential risk:

_____ The potential of allowing access to brokerage level data editing capabilities.
_____ Transaction Coordinators / IMLS Member can also be actively practicing real estate, as they are licensed agents.

*Security Levels: **LEVEL 3:** Basic MLS access, no editing capabilities | **Level 4:** Access to input and edit MY OWN LISTINGS (or another agent's through Assume Identity) | **Level 5:** Access and editing capabilities to all BROKERAGE LISTINGS | **Level 6:** Access and editing capabilities to all FIRM LISTINGS (Main office and branches)
